Amendments to the RFP:

The following amendments are hereby made to the RFP. Added language is underlined. Deleted language is marked with a ~~strikethrough~~.

Section I – Basic Information and Timetable

The paragraph entitled “Contract Start Date” is hereby amended to read as follows:

~~The anticipated date for service to~~ Service shall begin is no earlier than July 1, June 30, 2010. Service shall begin ~~no later than~~ within thirty (30) days after registration of the Franchise Contract with the New York City Comptroller (“Comptroller”).

Section II – Summary

The last paragraph of the section is hereby amended to read as follows:

The Franchisee shall charge a fare(s) for service which fare(s) shall be no higher than the uniform maximum fare set by the Department at \$4.00 per ride. The uniform maximum fare may be amended from time to time by the Department with the approval of the FCRC. The fare structure proposed, including any reduced fare program(s), shall be subject to the approval of the Department and shall be memorialized in the Franchise Contract. Changes to ~~the any fare or~~ any fare or fare structure during the term of the Franchise shall be subject to the prior written approval of the Department. Advertising will be permitted on the inside and/or outside of the vehicles used for this service subject to specific criteria

and limitations detailed below and contained in the Franchise Contract. The Franchisee shall pay to the City as compensation for the Franchise a percentage of the gross revenue derived by the Franchisee from the Franchise, as described more fully below. The Franchisee shall receive no subsidy from the City.

Section IV – Revenue and Compensation

The following sentence is hereby added after the second paragraph:

The maximum one-way fare under the current franchise is \$2.50.

Section V – Proposal

A (6). Compensation Proposal

The first paragraph is hereby amended to read as follows:

The proposal shall state the proposed compensation for each year of the term of the Franchise, including renewals, as a percentage of the Gross Revenues. A percentage of net receipts will not be acceptable.
