

This is ADDENDUM #2 to the above referenced Request for Proposals (RFP), of which you have obtained a copy.

The following questions and answers were inadvertently omitted from Addendum #1, issued on 3/19/10.

1. **QUESTION:** Will NYC & Company be involved in this year's program?
ANSWER: Based on previous experience, DOT does not anticipate a large amount of involvement by NYC & Company.

2. **QUESTION:** Is there a minimum sponsorship cost to be paid by all sponsors and partners?
ANSWER: No.

3. **QUESTION:** Is the incumbent event planner participating in this year's RFP?
ANSWER: This is an open competitive procurement. DOT does not know which companies will propose.

4. **QUESTION:** Is the \$175,000 allowance for smaller events spread over the three-year contract term or does it apply only to the first year?
ANSWER: This portion of the budget is spread out over three years and to be used by DOT as determined by the agency's needs.

Prospective proposers are advised that no additional questions concerning this RFP will be considered.
