Amendments to the RFP:

The Due Date is hereby extended to Monday, May 10, 2010. The time and location of submission are unchanged.

Answers to Written Questions:

1. *What is the current rate that the current carrier is paying the city for the route between Williamsburg and Borough Park?*

The current franchise contract requires the franchisee to pay to the City as compensation for the franchise:

- (a) 3% of gross receipts, defined as the gross revenues derived from (i) the operation of buses on the franchise route; (ii) advertising in the interior of those buses; and (iii) charter and contract bus operations operated by the franchisee wholly within the City of New York; and
- (b) 5% of gross receipts derived from advertising on the exterior of the buses operated on the franchise route.

2. *Would it be possible to get a copy of the attendees that signed in to the Pre-Proposal Conference?*

3. *In the RFP, for Financial Statements, it states that "The proposer(s) must submit audited financial statements for its two most recent completed fiscal years." It would be an impossibility to get audited statements by the deadline.*
